#### **Ordinance 2021-06-08-1 was read**

A discussion was held by Jerry Voegel Who voiced his concerns over gutters, alley ways, grass in gutters and railroad grounds.

Derek Voegel wanted to know who was responsible for Johnson grass in the streets.

Justin Collins responded to all questions and concerns. He referenced many of the question back to the Towns legal Council for a correct answer.

In response to Jerry Voegels question concerning the railroad property. Christy Foster explained the court battle continues and railway has abandoned property and wants too not be responsible for the up keep. Yet they request rent for water lines and sewer lines on abandoned railway and none working rail way.

Bruce said that when they abandoned the railway the town did the initial clean up. But it currently still belongs to the railway till suit is settled.


