William Bender felt with current law suits pending there was no need to rush to acceptance. William had conversation with Tent Van Haaften and felt we should wait. Under advisement board agreed to table these Ordinance amendments.

Motion was then made by Bruce Baker to table this request of acceptance for the Amendments to the Wind and Solar Ordinance 2<sup>nd</sup> by Justin Collins.

Ordinance N0.2021-06-08-1 Weed Control Ordinance: Ordinance was read by council President. William Bender discussed new Ordinance changes. He has requested that The Town publish Ordinances in the paper two times prior to next meeting. He said at next meeting in July we could vote on this Ordinance. He had rewritten the whole thing over due to requested changes by Officer Carter and Justin Collins. William verified changes requested were from council. "Page 3 Paragraph 4d'. Mike Baehl replied that due to cost of certified letters on repeat offenders cost is not affective. He had requested that change.

Ordinance will be voted on next meeting

Ordinance No. 2021-06-08-2 Garbage and Trash control: Ordinance was read by council President. William Bender discussed new Ordinance changes. He has requested that The Town publish Ordinances in the paper two times prior to next meeting. He said at next meeting in July we could vote on this Ordinance. Bill addressed changes. The timing for lien placement was six months has now been changed to one month. William discussed his struggles with defining garbage and trash. He settled on garbage defined as "organic matter that can decay. Trash as defined in 'Websters Dictionary' waste with no value.

Bruce wanted to know if we had a pile of 2x4 how is that considered. William said it would be of value so not trash as defined.

Bruce: Marshal has to us logic to enforce with documents for guidance.

William: and direction from council.

Police Department: no report at this time

**Utilities**: Diana Powell Utility Manager was on hand to give a report on the sprinkler credit. Sprinkler credit will be for the usages of June, July, and August. Billed on the months of July August, and September. The sewer rate is figured by the computer based on the average sewer usage. Bruce asked Diana to check with Pat Callahan on whether the sprinkler credit was figured in the rate change. If not, we would need to Amend the rate changes.

Justin Collins talked about the Duke Energy plan for pole replacement of 116 poles. These lights will be replaced with LED lights, with a cost savings monthly of round numbers \$600.00 a month. Christy Foster has been in contact with Crane Credit Union for the loan. It should be ready tomorrow for council's signature. Loan was procured for \$50,000.00. Christy will be contacting council for signatures when loan documents are available.
